## Poets Cove Resort & Spa Package Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

### Eligibility

The Poets Cove Resort & Spa Prize Package Contest (herein referred to as the “Contest”) is open only to those who fill out the [“2020 Virtual Pride Community Feedback”](#) form and are 19 years old as of October 28th, 2020.

The Contest is only open to legal residents of Canada and is void where prohibited by law.

Employees of Vancouver Pride Society (VPS), their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

### Agreement to Rules

By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of VPS, as final and binding as it relates to the content. The Contest is subject to all applicable federal, state and local laws.

### Contest Period

Entries will be accepted online starting on or about October 2nd, 2020 and ending October 28th, 2020. All survey entries must be received by October 28th, 11:59pm PDT.



## How to Enter & Contest Requirements

The Contest must be entered by submitting feedback to the “2020 Virtual Pride Community Feedback” form. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. The form must be completed in full, to the best of the submitters ability and must contain a phone number in order for the winner to be contacted. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of VPS.

You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, phone numbers, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of VPS.
